Statistical information of the Special Appeals Chamber on registered cases and rendered decisions

The Special Appeals Chamber continues to exercise its function in the process of re-evaluation of judges and prosecutors, following the submission of the appeals filed by the assesses or the Public Commissioner against the decisions of the Independent Qualification Commission.

As of December 31, 2024, the Special Appeals Chamber has announced and delivered 296 decisions corresponding to the Re-evaluation Jurisdiction, of which 12 decisions were announced in 2018, 34 decisions were announced during 2019, 42 were announced decisions during 2020, 38 decisions were announced during 2021, 49 decisions were announced during 2022, 55 decisions were announced during 2023 and 66 decisions were announced during 2024 (*1 decision for the review of decision of the case on the merits*). As of December 31, 2024, the Special Appeals Chamber has registered 417 cases corresponding to the re-evaluation jurisdiction, 40 cases during 2018, 62 cases during 2019, 63 cases during 2020, 86 cases during 2021, 53 cases during 2022, 57 cases during 2023 and 56 cases during 2024.

With regard to the Disciplinary Jurisdiction, as of December 31, 2024, the Special Appeals Chamber has registered 22 cases of this Jurisdiction, of which 2 cases were registered in 2018, 1 case in 2019, 11 cases during 2021, 2 cases during 2022, 4 cases during 2023 and 2 cases until 2024.

Up to December 31 2024, the Special Appeals Chamber has rendered a total of 18 decisions corresponding to the Disciplinary Jurisdiction, 9 final decisions and 9 decisions for non-transference of the case into public hearing. During 2018, there were announced 2 decisions: 1 final decision and 1 decision for non-transference of the case into public hearing; during 2020, there was announced 1 final decision; during 2021, there was announced 1 final decision and 3 decisions for non-transference of the case into public hearing; during 2022, there were announced 3 final decisions and 4 decisions for non-transference of the case into public hearing; during 2023, there were announced 3 final decisions and 1 decision for non-transference of the case into public hearing; Juring 2023, there were announced 3 final decisions and 1 decision for non-transference of the case into public hearing. During 2024, there was rendered no decision of the Disciplinary Jurisdiction.

As of December 31, 2024, the Special Appeals Chamber has registered a total of 439 cases corresponding to both jurisdictions, 417 of which were cases of the Re-evaluation Jurisdiction and 22 of which were cases of the Disciplinary Jurisdiction. As of December 31, 2024, the Special Appeals Chamber has rendered a total of 314 decisions for both jurisdictions, 296 decisions of the Re-evaluation Jurisdiction and 18 decisions of the Disciplinary Jurisdiction. As of this date, the Special Appeals Chamber has under review a total of 125 cases, 121 of which correspond to the Re-evaluation Jurisdiction and 4 of which correspond to the Disciplinary Jurisdiction.
