## Periodic information on registered cases and decisions of the Appeal Chamber

The Appeal Chamber continues to exercise its role in the vetting process of judges and prosecutors, following the lodging of the appeals by the assessees or the Public Commissioner against the decisions of the Independent Qualification Commission.

As of June 30, 2025, the Appeal Chamber has announced 346 decisions of the Re-evaluation Jurisdiction, of which 12 announced in 2018, 34 announced during 2019, 42 during 2020, 38 decisions during 2021, 49 decisions during 2022, 55 announced during 2023, 66 decisions during 2024 (1 revision decision on the merits of the case) and 50 decisions until June 2025.

The Appeal Chamber has registered a total of 417 re-evaluation jurisdiction cases, of which, 40 cases during 2018, 62 cases during 2019, 63 cases during 2020, 86 cases during 2021, 53 cases during 2022, 57 cases during 2023 and 56 cases during 2024 (there are no cases expected to be registered with the Chamber after December 31, 2024).

With regard to the Disciplinary Jurisdiction, as of June 30, 2025, there are 24 cases of this Jurisdiction registered with the Appeal Chamber, of which, 2 in 2018, 1 in 2019, 11 during 2021, 2 during 2022, 4 during 2023, 2 cases during 2024 and 2 cases during 2025.

As of June 30, 2025, a total of 19 decisions of the Disciplinary Jurisdiction have been delivered, 9 final decisions and 9 decisions not to transfer the case in a plenary hearing. During 2018, 2 decisions were announced: 1 final decision and 1 decision not to transfer the case in a plenary hearing; during 2020, 1 final decision was announced; during 2021, 1 final decision and 3 decisions not to transfer the case in a plenary hearing were announced; during 2022, 3 final decisions and 4 decisions not to transfer the case in a plenary hearing were made; during 2023, 3 final decisions and 1 decision not to transfer the case in a plenary hearing were made. During 2024, no decision of the Disciplinary Jurisdiction has been made. As of June 30, 2025, 1 decision not to transfer the case in a plenary hearing was made.

As of June 30, 2025, there are a total of 441 cases registered with the Appeal Chamber for both jurisdictions, 417 of which are Re-evaluation Jurisdiction cases and 24 Disciplinary Jurisdiction cases. As of June 30, 2025, there are a total of 365 decisions issued by the Appeal Chamber for both jurisdictions, 346 decisions pertaining to the Re-evaluation Jurisdiction and 19 decisions of the Disciplinary Jurisdiction.
